It is an electronic spread sheet written in Extended BASIC and is available on disk or cassette. This spreadsheet has 33 rows and 14 columns. The kit includes a bare printed circuit board, software, and manuals and costs \$50.00. For orders of 5 or more, the cost is \$42.00 each. The kit requires about \$70 to \$90 of additional parts to complete if you want 90K storage (Single Sided) and \$105 to \$130 for 180K storage (Double Sided). If you'd like to buy a complete one the cost is \$180. for single sided and \$230. for double. They sent a few flyers, which will be at the meeting.

### WHO WE ARE:

We are a non profit organization whose membership is open to anyone interested in the activities of the group. All members pay annual dues of \$12 for individual and for family's are \$15. The membership year is Jan. - Dec. You are invited to attend a couple of meetings before deciding if you wish to join. OUR MEETINGS: Our meetings are on the second Thursday of each month, at 7:00 PM, in the county courthouse at the corner of 10th and San Antonio, on the second floor. Each meeting starts with club business and is followed by a demonstration or talk. The second meeting of the month is our special interest group, the assembly language SIG. Everyone is urged to share information on topics related to the TI 99/4A -- software review. hardware availability, programming tips, etc. MEMBERSHIF: You may join as an individual or as a family unit. Each membership "unit" has one vote in club matters and only one person from a "unit" may hold club office(on the other hand your entire family is invited to serve on club committees and participate at meetings and in meeting planning!). Our monthly newsletter is available to members at the first monthly meeting and is sent to those who don't attend. At meetings, you may buy C-10 cassettes for \$.75 each, 5 1/4 " disks for \$7 each box. We buy these items in bulk quantity and charge cost plus enough to keep several of each item in our library. OUR LIBRARY: Currently, our library is located at the librarian's house and will be available at each of our meetings. Our library has some TI command modules and 350 programs on disk and tape. Roughly half of the library's programs will run on just the console (some may require joysticks) and most of the others only require the Extended Basic module. We have programs of all types( games, education, scientific, and business and household management) and we poll the membership's interests before purchasing more. Above all, we are a membership organization. We depend on everyone for directions the group should go and activities we should undertake. Join our group and share your ideas!

# Central Texas 99/4A Users Group General Membership Meeting March 13, 1986

The March meeting of the Central Texas 99/4A Users Group was held on Thursday, March 13, 1986 at the Commissioner's Court Room of the Travis County Courthouse Annex building. The meeting was called to order at 7:35 PM by the Secretary, Mike Schultz. Shortly afterwards, the President, Joe Pizzi arrived and assumed control of the meeting.

The minutes of the February meeting were read by the Secretary, Mike Schultz.

The Treasurer, Faul Dunn, gave a treasury report.

There was discussion about raising the yearly dues to \$15.00 and eliminating the family classification. This would require a change to the constitution which couldn't be voted upon until the April meeting.

There was also discussion about an "Adopt a Users Group" program. Falling membership is making it difficult to justify trading newsletters with other groups. The idea for the program is that a member essentially picks another users group to adopt, that is, they pay for duplication and postage cost to mail our newsletter out. This would allow our Users Group to continue to trade with others. Nothing was decided on this issue.

There was discussion about the nearly 1 to 1 ratio of members to users groups on our mailing list.

There was discussion about purchasing an electric stapler to make mailing the newsletter easier. There was nothing decided on this issue.

There was discussion about the hardware swap and setup seminar and about the mixup of the date in the newsletter.

There was discussion about asking for a donation at the door to assist the Group's treasury. The general consensus was that this wasn't a good idea.

Foley Broaddus announced that TI is closing their Calculator Exchange Centers nationwide effective March 22, 1986. In the future all equipment will need to be sent to Lubbock for repairs.

There was vote on the day of the hardware swap and Sunday, March 16, 1986 was decided.

There was discussion about the Austin Computer Faire. This year they have invited the group to have a booth again and they are offering a free meeting room to allow us to have our June meeting there. Unfortunately, they also want some money this year to cover the cost of the booth. About \$99.00 if they supply everything. However if they supply the carpet, drapes, sign (all required) and electricity, and we supply the tables and chairs, we can reduce the cost to \$75.00. It was decided that supply the tables and chairs was the correct thing to do, and we could raise the rest of the money.

Fund raising discussions began again. Again nothing was decided.

There was discussion about reducing newsletters costs by handing newsletters out at the meetings. The following motion forwarded: To change the newsletter delivery to that of the meeting and subsequently mail newsletters to those who can't attend. There was a vote and the motion passed. Joe Fizzi directed Mark Milam, the newsletter editor, to not implement this policy until the May newsletter. This would allow everyone to be notified of the change in the April newsletter.

The meeting adjourned at 8:28.
