Although this would not have been enough to really get me hopping mad, it was the matter that they owe me an Editor/Assembler package and some other software items which I had or dered. (at last years prices yet!!!). Which brings up some points worth pondering: How can a company, with over 12,000 members (my number is around 12,400) go bankrupt? With a capital of over \$200,000 in just membership fees alone. I find this rather hard to believe. Not only that, but they sold hardware and software (TI, Third Party, and Owner written). From the last notes, they had just purchased a mainframe, and apparently increased

2. The debtor shall appear in person (or, if the debtor is a partnership, by a general partner, or, if the debtor is a corporation, by its president or other executive officer) at that time and place for the purpose of being examined.

YOU ARE FURTHER NOTIFIED THAT:

The meeting may be continued or adjourned from time to time by notice at the meeting, without further written notice to creditors.

At the meeting the creditors may file their claims, elect a trustee as permitted by law, elect a committee of creditors, examine the debtor, and transact such othe business as may properly come before the meeting.

As a result of the filing of the petition, certain acts and proceedings against the debtor and his property are stayed as provided in 11 U.S.C. §362(a).

Unless the court extends the time, any objection to the debtor's claim of exempt property (schedule B4) must be filed within 30 days after the conclusion of the meeting of creditors or the date of the filing of any amendment to the list of exempt property.

MORE TRASH From - MICROPENDIUM

TI has apparently trashed its remaining inventories of cartridge based software. Reports are that a number of railroad cars were seen leaving Lubbock, Texas, with the remains of tens of thousands of smashed modules. The train is bound for Providence, Rhode Island, where the cartridge are to be buried.

TC-99/9 MICROPENDIUM

A TI 99/4A compatible coputer have been announced by Tex Comp Users Supply Company of Granada Hills, California. They were shown at the Consumer Electronics Show in Chicago. The design is based on the IBM PC like enclosures. There are three configurations of the compatibles: TC-1, TC-2, and TC-3.

TC-1: heavy duty regulated fan cooled power supply, two double sided, double density half height drives, and a read panel of six surge and spike protected electrical outlets, each controlled by a switch on the front panel. Retail is $$450.00 \ (us)$.

TC-2: CorComp 9900 system and TE speech synthesizer built

in along with the features of the TC-1. Retail \$750.00(us) TC-3: upgraded TC-2 with 128K ram and buffer board added. Retail is \$875.00(us).

The TC-99/9 is basically the TC-3 128K with modified 40/80 column TI processor board and designed to accept the new Wico smart keyboard which has a 10 key pad and built in Track ball. It is 128K fully compatible and with a color monitor, retailling in the \$1,300 - 1,500 range (us.).

Then type in NEW, OLD EXPMEM, and RUN the program. You are saving the program into memory expansion, fooling the computer into thinking the disk drives are not hooked up, then reloading the program. If still memory full, then sorry. You can get the drives back by typing in CALL LOAD (-31888,55,215).
- John Behnke of 5755 W. Grace, Chicago, Illinois 60634 has developed a new game for the Tunnels of Doom Cartridge. The game is called "Tomb of Death" and sells for \$8 (us) on disk or cassette. TI ASSESSED \$12 MILLION MICROPENDIUM

Texas Instruments Inc. agreed to pay \$12 million to settle a class action suit which claimed that company officers misled investors by not disclosing unfavorable information that led to TI's forecast of a major loss in its home computer business last year. The agreement was reached in early October of 1984.

the suit, brought by the Council on Social Work Education Inc, named TI chairman Mark Sheppherd Jr., chief executive officer J. Fred Bucy, controller Marvin Lane and Jim Fischer, former executive vice president.

The suit alleged that the men knew but failed to tell potential investors that sales of the TI 99/4A were flagging and that profit margins were cut because of price cutting. TI announced June 10, 1983 that it would lose up to \$100 million on its home computer business.

The settlement was filed in the U.S. District Court in the Northern District of Texas. Court approval is still required. A hearing was planned for Jan. 18, 1985.

A TI spokesman said the defendants denied the allegations in the ocmplaint and that the settlement was reached to avoid the expense of litigation and "the diversion of managment time".

Under the settlement, the \$12 million will be distributed to an unknown number of investors TI stock, put and call options between March 1 and June 10, 1983.

TI stock plummeted some \$50 per share within two days of the company's announcement of its anticipated losses, from \$157.75 per share to \$107 per share.

RAM CARD FROM THE SOURCE

An 8K Ram / single stepper board is now being manufactured for the TI 99/4A.

This board provides Ram at >6000 to >8000 (same address as ram in the cartridge port). It may be used for any environment which does not make use of this address space. That means no XB.

This provides DEBUG the capability to single step through code using the "S" command.

The board is powered from the console expansion port. It is an open construction epoxy glass double clad board. It is fully exposed with no case, so you must either add your own case or be very careful in handling.

Two switches.. one to turn it on/off and the other to activate the load interrupt.

It is used to place programs such as DEBUG to examine code in other parts of memory when they are very large or manipulate memory to prevent yo from examining them.

This is a tool for the advanced programmers and you would need a specific application. Price is \$73.00 (us) and info from Chris Caletka, 511 Martha, Euless, Texas 76040, (817) 267-8338 (Specialty Services).
