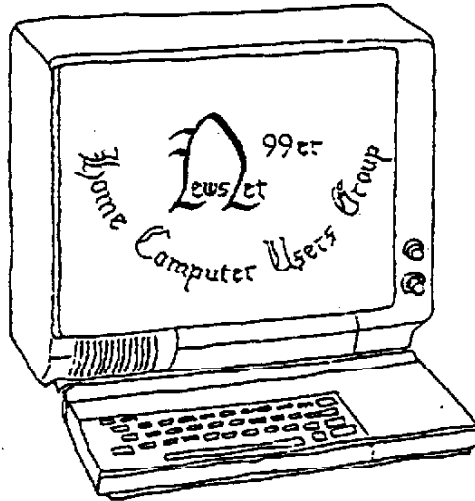

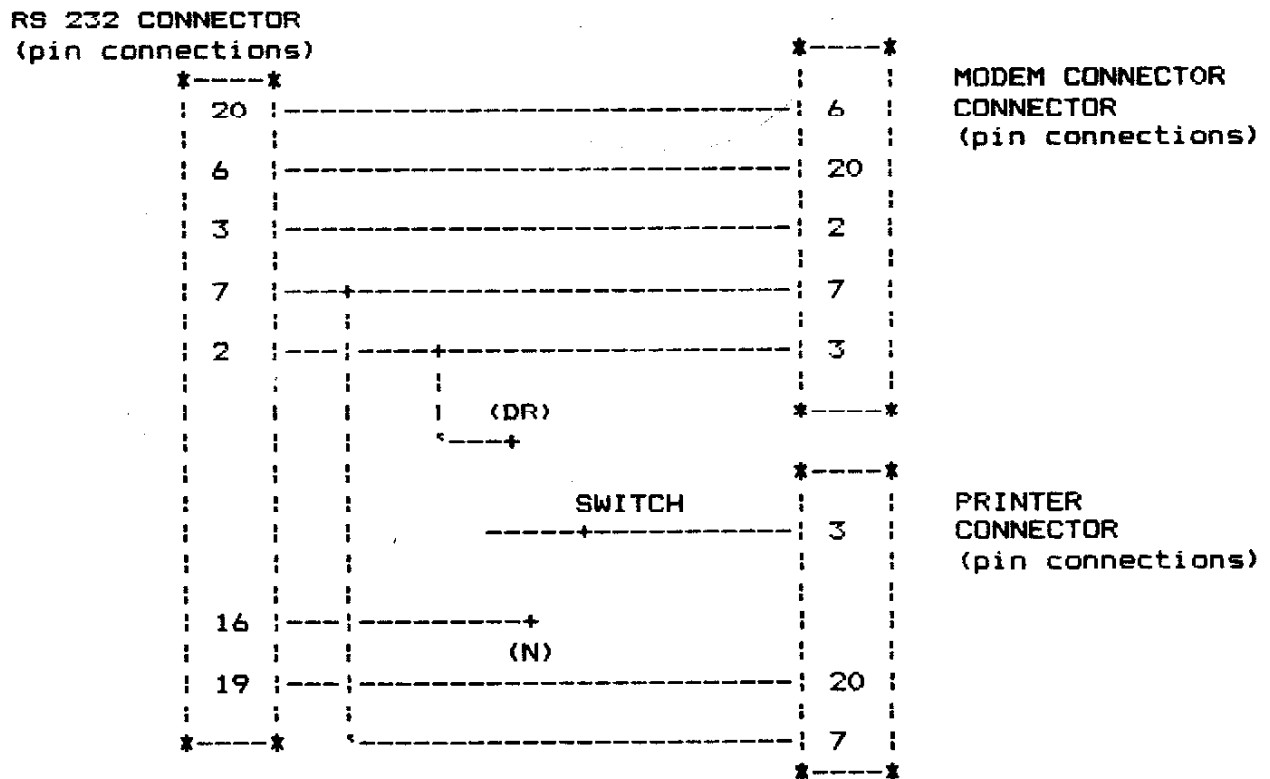

Another option for a modem connecting cable allows you to both serially communicate and serially print, (using the RS232 serial port), at the same time. A switch allows the printer to use either the normal (N) data path or to look at the directly recieved (DR) data coming from the modem. This cable requires three DB 25 male connectors. The switch can be installed in the RS232 DB 25 connector hood if a very small switch is used. Wire the cables as shown below:

REVIEW OF TC-MAIL

When I saw the advertisement for TC-Mail, I was quite eager to investigate it. This was the first mail list program that I had encountered that was written in FORTH. Due to FORTH being a public domain language nearly everything written in FORTH comes free. However \$9.95 plus 1.50 S/H is almost free.

When I ordered this program, I hoped for two things. First, with this program being written in FORTH, I expected to be able to learn

more about writing in FORTH (I failed to notice that the ad said it was BSAVED). Next I hoped for a super mail list based on the number of records per disk which were advertised. Many other features were also mentioned.

I feel like I lost on all counts. In starting out the program looks excellent and contains many neat features. It will initialize disks and also write dummy files on them from within the program itself. The data entry and score-keeping is also quite good. Then comes the print options--it looks like he subcontracted the print routines out to an illiterate 4-year old. The labels option yields only 3-line labels with no possibility for expanded address or attention lines. The phone list is just that--names and phone numbers only. Now who wants a phone list without addresses. The other option--print records--will print out all the other 'unused' information plus that which you have seen before, all jammed up onto two lines.

I admit up front that I didn't pay close attention to the advertisement in the area that the program is BSAVED 'for fast program loading.' This is another way to say that studying/alteration of the program is considerably more difficult. Now I must learn how to un-BSAVE the screens of interest. The by-product of the whole adventure is that I may learn more about FORTH by forcing myself to study how to change this program.

In conclusion, this program did not do either of the two things that I had hoped it would when I bought it. I can not judge its performance with large numbers of entries because I didn't want to waste the time necessary to make a large number of entries. The program is cheap enough, but it is worth nothing to me.

TIMELESS TECHNICAL TIPS by LeRoy Thompson

When I thought of this title for a column, I thought it would serve for anything that I wanted to write. However, I am afraid that some non-technical thoughts may creep in.

Once again, apologies. It seems that my boss is getting quite unreasonable--he expects me to work on the company's business ahead of researching a replacement connector for the GROM port. That's the main reason that I haven't done the final search yet. Maybe next month.

I have several more things to say about the Qume disk drives mentioned last month. First and foremost--they are down to \$70 now and I think that you can do even better. See Dick Webber for the latest good deal (485-5750). I know of at least two cases where the modification has been successfully done. I also know of one where a minor catastrophe resulted and caused secondary damage. It has all been successfully repaired now and is working. The point is that if you elect to make the power supply modification--please exercise great care in component layout and check for shorts prior to applying power. There isn't much room left for extra heat sinks. The best version that I have seen are the clip-on variety that Dick Webber

bought at Delta. They take up the least room.

I called and placed an order with Triton toward the end of April. I was warned that one item was on backorder. As of the 17th of May the entire order arrived (in two separate shipments). That's not too bad for service. Triton has the advantage of a large inventory, but their prices reflect their attitude that it's a seller's market. But, if that's the only place to get something . . . One word of warning. When dealing with this California firm you must pay TEXAS state tax. They claim that it is because they have assets in Texas. Whatever the reason, it just doesn't seem fair.

I may just start seriously considering purchase of the Myarc 128K memory card. It is supposed to come with software which will allow it to simultaneously perform as a printer spooler and RAM disk. It is also expandable to 512K. If anyone has had experience with this card, please let me know. Thanks.

It is our current desire to ship all in-house orders for Owner Written & Translated software to our members prior to May 30, 1985. There will not be enough capitol to refund any full or partial membership dues. All creditors will be notified by the court as to the division of assets.

The entire Software Library has been kept in tact and active I.U.G. members will be notified by a new supplier how they can continue to purchase these items should they desire to do so.
